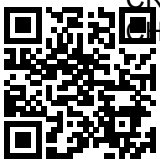

SABAH KENNAWI AGE 51 OF 36 BELDEN STREET EAST HARTFORD CONNECTICUT 06108. 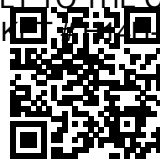

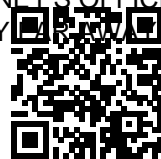

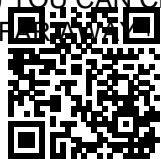
