It was just awful, incomprehensible, bewildering. I was so upset by all that he did, and I am guessing that my being upset was maybe what he wanted, although I have no idea why. It was like living with a spoiled, evil four year old who was having a temper tantrum while possessing the keys to the house and the only access to the electrical controls. The state police officer said he was known to act.



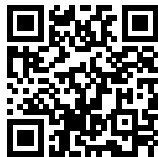

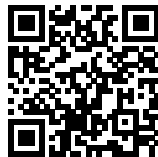

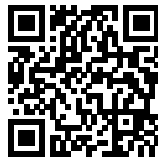
