Their duties include: assisting the Transit operations manager and line supervisors with the controlling of movement of fixed-route vehicles, accepting calls requesting general information, and ensuring timely, effective, safe service at all times.

**Van Operator (Driver/Monitor):** The Driver/Monitor is the front-line provider of service for the organization. The Driver/Monitor is responsible for the safe, caring, and efficient transportation of all riders under his or her care, and for maintaining a professional, courteous demeanor when interacting with all staff, programs, and riders.

## Qualifications

Ability to drive a van and maintain a valid Massachusetts Driver's License required. Having had a valid driver's license for at least 3 consecutive years immediately prior to hire. Excellent driving skills required, as evidenced by a satisfactory Driving Record and Road Test.
