I can't tell you how many people call our office to ask questions about their legal problem or their near approaching hearing or one they attended without counsel. A parent tried to defend a Petition for Child Support for one child and walked out with a \$720.00/mo. obligation against him. His obligation until the child turns 18 will exceed \$100,000.00.

A spouse obtains a Protection from Abuse Order against their spouse and he/she has to immediately vacate the marital home which is owned by the both of them! In one case, the spouse who had to vacate had to live in his car until his Court hearing 6 weeks later.

There are far too many more stories to tell. What we tell everyone who calls us in advance of their hearings is that it becomes more expensive and challenging to undo what happens in Court than if they had legal representation at their first hearing. Some judicial decisions are irreversible.

If you have a legal problem, you do not need a lawyer. You need to go to Court. You need to go to the group of folks who wished to go before the judge in Court on their own. Who did not have a lawyer and was not represented.

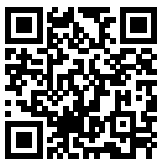
