We cover the entire Bay Area and try to make it easy for you to get your papers to us and get your case moving forward. We also provide pick-up of your papers in most of the Bay Area, usually the same day, but almost always within one business day. If you want to be sure to have your papers picked up the same day, please call any time

We serve all legal papers, whether family law, small claims, larger state or federal cases, whatever, and can help you collect your judgment afterwards.

In most cases we file the proofs of service at no charge with the court clerk and send you the file-endorsed copy.

We can help you collect judgments. Our terms are very favorable. Unlike some collectors, we do not ask you to sign over your judgment to us. Assuming you know the location of the judgment debtor's assets, a bank account or employment information, we can levy on the bank or obtain a wage garnishment very quickly. Our fees for this service as well as the court and sheriff's fees can be added to your judgment. We also prepare, file and serve Orders of Examination and Abstracts of Judgment for the more difficult cases. We also have searched for our skip-trace.

By the way, in the Bay Area counties, sheriff's deputies do not serve the judgments, writs, orders and writs on banks, and the sheriff's office administer the case and do not serve them, but we generally do nothing else and, even in those counties where the sheriff's office can do the serving, we serve faster than they would.

We will stake out premises to catch an evasive person at an hourly cost that is lower than nearly every other firm in the Bay Area.


