I am uninsured, is there a self-pay option?

Self-payment options are available for individuals subscribing to insurance plans that we do not participate with, or for those who are uninsured. The initial evaluation cost is \$50.00 and subsequent physical therapy sessions are \$50.00(per week)/no carry overs
