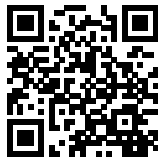

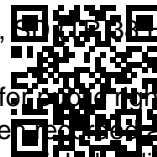

NE 1/4 of Section 24, T2N R6E, B2M Harding County, SD 57433 (VR)  
 Easements: State of South Dakota provide for a right of way access along all property lines. In addition, private access easements have been granted across private lands. An actual road, however, may not currently exist and access might be difficult at certain times due to having to cross the creek.  
 Mineral Rights: A previous rancher reserved 50% of any mineral rights he might have owned and thus a new buyer will receive the other 50%.  
 Surveys: This parcel was surveyed and the map recorded in the county.

Property Taxes: Approximately \$4/acre annually
